Communicating openly to build trust and inspire confidence.

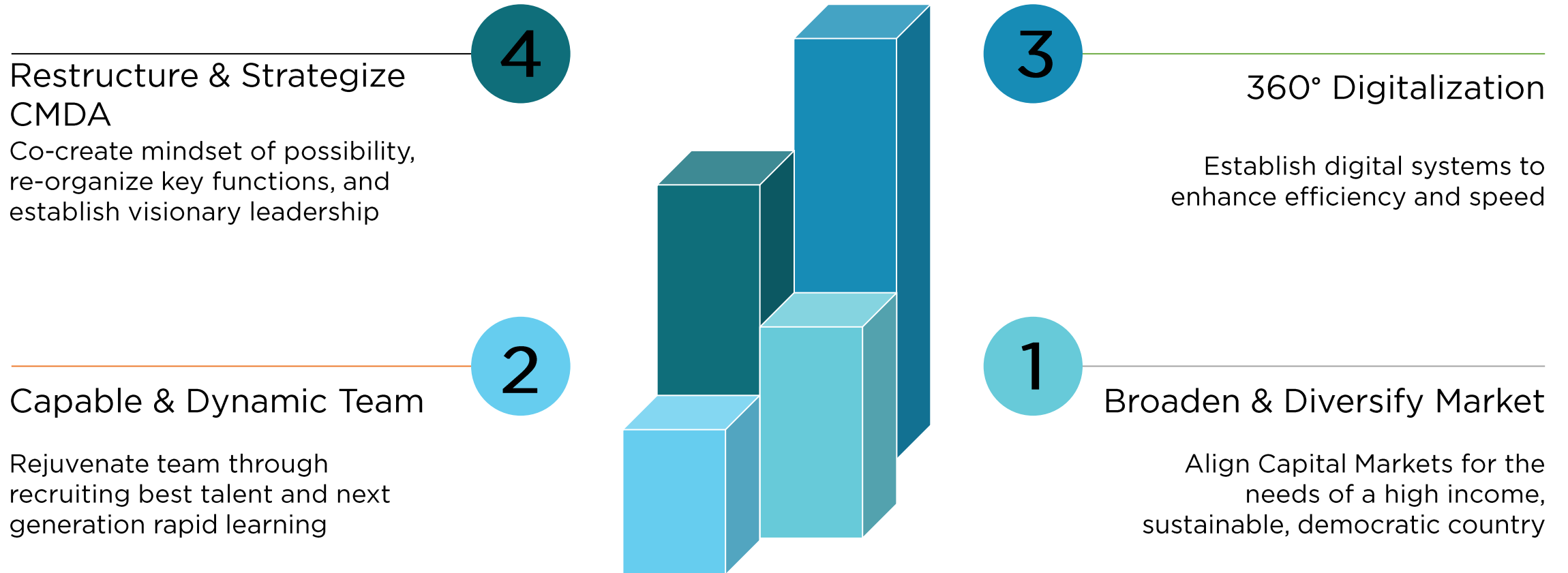
